To meet Peru State College's satisfactory academic progress requirements, you are expected to complete a degree within a maximum allowable time frame. The maximum allowable time frame is reached for undergraduates who have attempted 180 credits and graduates who have attempted 54 credits. You are ineligible for all types of financial aid including grants, loans, and scholarships.

Once you have reached or exceeded the maximum allowable credits attempted, Peru State College will consider funding **only** for courses required for your degree. In most cases, students will not be funded to finish second majors, minors, or courses taken for personal enrichment unless they can demonstrate the courses are necessary for future employment.
